Who can apply?

We would like to invite farmers, artists and crafters to showcase their wares, talents and/or services at the Harvest Market. *All items must be handmade by you, grown on your farm, or locally produced.*This is a juried show as space is very limited. Please get your applications in early!

Vendor Spaces:

Booth size is 10' x 10' outdoors on the grassy lawn. Vendors are responsible for supplying thier own tents, tables, chairs, etc. Tents are not required, but are higly recommended. Electricity is available upon request (additional \$10). Booth sharing is allowed with you and one other vendor, but you must both submit examples of your work for approval.

Booth Fee: \$40 (check or credit card)

Your payment will not be deposited until you are accepted into the show.

Deadline: Booth application *due with payment by August 20th.*

Applications received after August 20th will be considered, as space allows, and booth fee will be \$50.

Event Set Up

Set-up time will begin at 8:00 a.m. Saturday morning. DO NOT arrive before 8 a.m. If you would like to start setting up Friday evening from 3:00 p.m. till 5 p.m., contact the Winery to make arrangements (for set up of tables and tents only; do not leave merchandise overnight). All vendors must be set up and ready to sell by 9:30 a.m. Saturday morning and must maintain their booth space until closing time at 5 p.m.

Vendor Displays

Vendors are to dress their spaces in a professional look with tablecloths over tables, inviting and attractively displayed wares, and clear signage. A banner or sign to identify your booth is recommended. To create a festive environment throughout the event, we encourage vendors to tastefully dress up their booths with autumn décor (corn stalks, pumpkins, gourds, hay bales, mums, burlap, for example).

There will be a contest for "Best Looking Booth"; judging will begin at 9:30 a.m. There will also be a "People's Choice" award conducted throughout the day. The winners of each will be awarded their booth space for free!

Load-in / Load-Out

Gate will open at 8 a.m. to allow vendor entry — please DO NOT arrive before 8 a.m. **Event assistants will guide you to your space. There will be helpers available to assist you with unloading your items to your space (as well as loading up at the end of the day).** We ask vendors to unload items to their space, MOVE YOUR VEHICLE to vendor parking area, THEN set up your space. There is limited area with a lot of traffic during set up, please be curtious to others while everyone is getting set up.

Event Rules

- · No pets allowed.
- Trash barrels and bags will be provided.

Please keep your area clean throughout the event and after packing up at the end of the day.

- Do not arrive before 8 a.m. Saturday morning (see Set Up info above).
- All cars must be moved to vendor parking by 9 a.m
- Vendors must remain set up until event closes at 5 p.m.
